Heard Shri K.G. Raghavan, learned Senior Counsel along with Shri Raghuram Cadambi, learned Counsel for R-5, Shri Nandish Patel, learned Counsel for R-1, Shri Aditya V. Bhat along with Shri Anind Thomas, learned Counsels for R-2 to R-4, Shri A. Murali along with Shri Andre Peter, learned Counsels for R-6 to R-10, and Shri Vishwajith Sadananda, learned Counsel for R-1 in Contempt Case No.02 of 2021 and Shri Arjun Rao, learned Counsel for R-6 in CC No.02 of 2021, through Video Conference.

A Memo for Withdrawal has been filed by the Petitioner and the R-1,

"2. The Petitioner submits that the present Company Petition was filed pursuant to certain disputes and misunderstandings between the Petitioner and the Respondents. These disputes and misunderstandings have now been amicably settled and clarified as a part of a settlement between the Petitioner and Respondents. Also, Respondent No.2 has now exited the Respondent No.1 Company by virtue of having transferred its shares to the Petitioner. The Respondent No.1 Company is therefore a 100% subsidiary of the Petitioner. Therefore, nothing survives for consideration in the present Company Petition. The Petitioner therefore seeks to unconditionally withdraw the present Company Petition including all allegations made against the Respondents.

3. The Petitioner further submits that with the withdrawal of the Company Petition, the pending applications in the Company Petition including IA 273/2019, IA 275/2019, IA 277/2019, IA 222/2020, IA 223/2020, IA 224/2020 and the Contempt Case No.2/2021 (filed by the Petitioner) and IA 495/2019 (filed by Respondent No.2), IA 494/2019 (filed by Respondent No.3) and IA 360/2020 (jointly filed by Respondent Nos.2 and 3), do not survive for consideration.

WHEREFORE, it is most respectfully prayed that:

A. The Petitioner may be permitted to unconditionally withdraw the Company Petition bearing CP No.102/BB/2019 and consequently prays the dismissal of all pending applications the and Contempt Case in the Company Petition in view of the settlement arrived at between the Parties, in the interests of justice and equity."

Hence, the CP No.102/BB/2019 is disposed of as withdrawn and the Contempt Case No.02 of 2021 does not survive and treated as closed.
