Playing on the popular Rapid format, the league's joint male-female teams will have the rare distinction of being a unique multiplayer team in the world of professional sports. In addition, the League will be the first ever Live televised chess event of its kind that will help offer fans a unique viewing experience. The inaugural season will take place at the prestigious Dubai Chess & Culture Club from June 21st to July 2nd, 2023.
